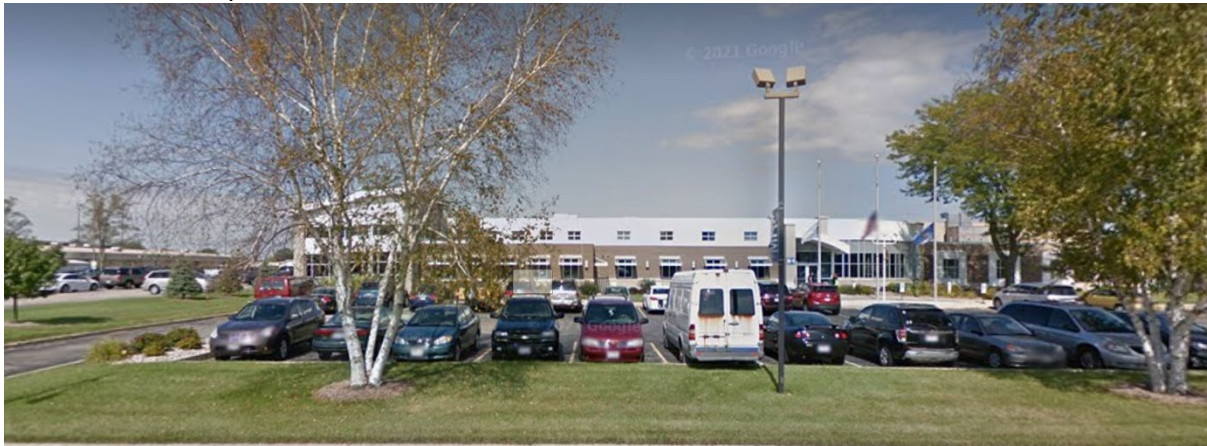
This section provides resources for those residing in Dodge County who wish to further their education after incarceration.

### **Moraine Park Technical College: GED/HSED**

*Wisconsin offers choices and options to adults who have not graduated from high school. Two of those options are the Certificate of General Education Development (GED) and the High School Equivalency Diploma (HSED). Adult Education is made up of multiple programs that serve adults ages 18-65+ who are seeking to improve their academic skills to obtain or improve their employment, earn a high school credential (GED/HSED), and prepare for college. Students may also work to improve their English language skills and get assistance with their college courses.*

**Important Information:**

You must be at least 18 1/2 years old by the date of the first class, or your high school class has graduated. Orientation is the first step to earning your GED/HSED. To schedule an orientation or book a registration session, go to the website and under GED/HSED you will find directions (<https://www.morainepark.edu/academics/ged-and-adult-education/ged-hsed/>). The orientation session is free. You will complete assessments and use those results to determine your next step.

Requirements for ALL GED and HSED Students:

- Be a resident of Wisconsin
- Be 18-1/2 years old or the person's ninth grade class has graduated
- Complete the GED/HSED Orientation
- Complete ALL REQUIRED Student Success Center activities
- Complete the Career Awareness course (For GED and all HSED options)
- Complete the Employability Skills course (For all HSED options)
- Pass the Civics test
